TERMS OF TRADING & CONDITIONS OF SALE

In consideration of Fagg's Geelong Pty. Ltd. (the Supplier) opening at my/our request a credit account in the name below, I/we agree to be bound by the following terms:

1. **STRICTLY NET 30 DAYS.** Settlement is due on or prior to the last business day of the month following the month of purchase/delivery of goods. Payments extending beyond the due settlement date will attract a Credit Carrying Fee of 14% per annum, commencing on the first day of the month following the month of purchase/delivery of goods and a Service Fee of \$2.00 per month. These rates may be varied by the Supplier from time to time. I/we agree to pay any reasonable expenses incurred in obtaining or attempting to obtain payment of any overdue amount, including debt collection and legal costs.
2. Credit facilities may be withdrawn without prior notice on overdue accounts or at the Supplier's discretion.
3. The Supplier supplies goods on the condition that property in the goods will not pass to the Company until they have been paid for in full but goods are at the risk of the customer or agent upon purchase/delivery. The Company irrevocably authorises the Supplier to enter any premises owned or under the control of the Company where unpaid for goods are located and to seize and take away such goods without being liable in trespass.
4. As security for any amount owing to the Supplier I/we hereby charge in favour of the Supplier all freehold and leasehold interest in land and any assets that the Company now or during the course of this agreement may acquire. The Company consents to the Supplier lodging a caveat or caveats noting its interests pursuant to such charge.
5. Any goods returned for credit must be in original condition, quoting the original invoice number. Special or cut orders are non-returnable.
6. Your account may be closed without notice if you do not use it for a period of twelve months.
7. Each invoice for goods purchased on a credit account shall be over \$10.00 in value.

5. This agreement shall be a continuing guarantee to the Supplier for the whole of the Company's debt to the Supplier from time to time in respect of goods and/or services supplied to the Company.
6. Each person who signs this agreement shall be liable under it whether or not any other intended signatory has also signed the agreement.
7. The liability of the Guarantor(s) under this agreement shall not be affected by any time to pay or any other concession granted by the Supplier to the Company or by any other failure on the part of the Supplier to enforce its rights against the Company.
